Special Call Meeting November 24, 2025 - Minutes**

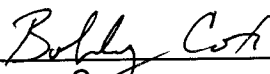

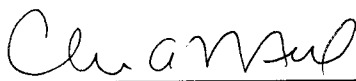
The Mayor declared that a quorum was not present and the meeting was dismissed.
